

On 04/24/2017, a vehicle operated by USA LOGISTICS INC, and driven by JASON R VESTAL, was inspected within the State of Ohio. As the result of discovery of the following violations of the Commission's rules, Staff of the Commission timely notified JASON R VESTAL (Respondent) pursuant to rule 4901:2-7-07, Ohio Administrative Code (O.A.C.), that it intended to assess a civil forfeiture against the Respondent in the following amount:
