

**BOND**

Pursuant to Ohio Revised Code section 4909.42, Cobra Pipeline Company, Ltd, a limited liability company duly organized and validly existing in good standing under the laws of the State of Ohio, ("the Company") as surety, hereby firmly binds itself to the State of Ohio as principal, to refund for the benefit of all customers of the Company who may transport natural gas through Company facilities, any amounts collected by the Company in excess of that amount that would otherwise have been due to the Company based upon the rates ultimately determined to be just and reasonable in this proceeding by the Public Utilities Commission of Ohio ("the Commission").

The above described obligation of the Company shall relate solely to amounts collected for transportation services provided by the Company during the period that begins July 1, 2017 and that ends upon the earlier of either March 25, 2018 or such date as the Commission docket an Order that establishes rates in this proceeding pursuant to Ohio Revised Code section 4909.19.

Furthermore, pursuant to Ohio Revised Code Section 4909.42, such refund, if any, shall take the form of a temporary reduction in the rate ultimately approved by the Commission, shall include interest at the statutory rate provided in section 1343.03 of the Revised Code, and shall be subject to the continuing and exclusive jurisdiction of the Commission.
