I have been authorized by T-Mobile Central LLC to request the rescission of the Delinquency Notice recently issued by the Commission regarding T-Mobile Central LLC Certificate No. 90-5450. See Attachment A.

T-Mobile Central LLC holds two certificates from this Commission: Certificate No. 90-5449 and 90-5450. On May 31, 2017, T-Mobile Central LLC filed its annual report for fiscal assessment for the year ending December 31, 2016 under Certificate No. 90-5449. See Attachment B.

It included a note on the cover page of the 2016 Annual Report to the effect that it holds two certificates from the Commission: 90-5449 and 90-5450. It indicated that all of the financial data for T-Mobile Central LLC for both certificates is contained in the annual report filed by T-Mobile Central LLC under Certificate No. 90-5449.

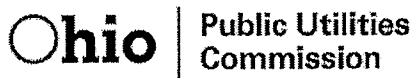
