



Emuna Energy also seeks to become channel partners with other certified electric generators so that the customer has numerous pricing proposals to consider. All billing is done by the certified electric generator, as with all collection. In some limited circumstances, Emuna Energy will be the exclusive agent of the business customer for purposes of pricing their electricity usage. Contracts with other customers will delineate whether Emuna Energy is their exclusive agent or whether it is acting on a non-exclusive basis. Emuna Energy will respond to any customer inquiries or complaints in accordance with the Commission's rules.
