**MOTION FOR EXTENSION OF TIME
FOR THE FILING OF THE
STAFF REPORT OF INVESTIGATION,
AND REQUEST FOR EXPEDITED CONSIDERATION**

The Staff of the Public Utilities Commission of Ohio respectfully requests that the date for the filing of its Report of Investigation into the Application in this case be extended. This request is made pursuant to Ohio Admin. Code 4901-1-13(A).

By Entry issued May 23, 2017, the Attorney Examiner set the deadline for filing the Staff Report for Monday, July 31, 2017. Due to the press of other business, Staff does not expect to meet that deadline. Consequently, Staff respectfully requests that it be given an extension of time in which to file its investigative report. Specifically, Staff requests that it be permitted an additional 30 days, or until August 30, 2017, to file its Staff Report in this case.

Pursuant to Ohio Admin. Code 4901-1-12(C), Staff further requests an expedited ruling on this motion. Staff has contacted all parties to this matter, and none objects to the granting of Staff's request for expedited consideration. Furthermore, Staff is authorized to represent that both Suburban Natural Gas Company and the Office of the

Ohio Consumers' Counsel also have no objection to the granting of the motion for extension of the filing date for the Staff Report.

WHEREFORE, Staff respectfully requests that this motion be granted without delay, and that the Commission issue an order granting its request that the date for the filing of the Staff Report of Investigation in this matter be extended until August 30, 2017.
