I. SUMMARY

{¶ 1} The Ohio Power Siting Board modifies the May 4, 2017 Entry in these matters nunc pro tunc.

II. DISCUSSION

{¶ 2} Hog Creek Wind Farm, LLC and Hog Creek Wind Project, LLC (collectively, Joint Applicants) are persons as defined in R.C. 4906.01.

{¶ 3} By Entry issued on May 4, 2017, the Ohio Power Siting Board approved an application filed by Joint Applicants seeking to transfer the certificate issued to Hog Creek Wind Farm, LLC to Hog Creek Wind Project, LLC.

{¶ 4} This Entry Nunc Pro Tunc is being issued to correct a typographical error in paragraph 11 of the May 4, 2017 Entry whereby the recipient of the transferred authority should have been denoted as Hog Creek Wind Project, LLC rather than Hog Creek Wind Farm Project, LLC. In all other respects, the May 4, 2017 Entry remains in full force and effect.


III. ORDER

{¶ 5} It is, therefore,



{¶ 7} ORDERED, That a copy of this Entry Nunc Pro Tunc be served upon all parties of record.




