**VILLAGE OF EVENDALE STATEMENT OF SPECIFIC CONCERNS PERTAINING TO  
CROSS-EXAMINATION**

Pursuant to Paragraph 19(a) of the Administrative Law Judge's Entry on June 21, 2017, in the above-captioned case, the Village of Evendale list the following specific concerns about which it may be interested in pursuing cross-examination of witnesses at the evidentiary hearing. The Village reserves the right to pursue additional issues at hearing that may arise based on pre-filed expert and factual testimony of the parties and any other issues raised during cross-examination. The Village presents its list of specific concerns as follows:

1. To avoid repetition, the Village of Evendale has reviewed the specific concerns advanced by The City of Cincinnati, Hamilton County, and Amberley Village. To the extent these concerns do not relate to specific parcels of property not in the Village of Evendale, the Village of Evendale incorporates these concerns by reference as if completely re-written here.
2. Regarding the location of the proposed alternate route, the Village has identified and communicated to Duke Energy Ohio several areas of concern. This includes the impact of the proposed route on the homes along Glendale-

Milford Road (and other neighboring streets), on the Kinetic Vision property, and on the Village Service Department building. The Village continues to maintain interest in the steps that Duke can take to mitigate damage to these properties.

3. The Village also anticipates that it may pursue cross-examination regarding the differences between the preferred and alternate routes.
