Dear Mr. Donlon and Ms. McNeal:

This letter serves as Dominion Energy Ohio's ("Applicant" or "DEO") preapplication notification letter in order for the Ohio Power Siting Board ("Board") to open a case for the proposed PIR 778 pipeline replacement project in the City of Canton and Canton Township, Stark County, Ohio. This letter is given at least five (5) days prior to DEO's filing of a Construction Notice.

In accordance with Ohio Administrative Code ("OAC") Rule 4906-6-03(A), DEO provides the following information:

**Project Description:** DEO is planning to replace approximately 3,376 feet of existing 8-inch diameter pipeline with 3,700 feet of 12-inch diameter pipeline. This project is located in DEO's existing easements and the public right-of-ways starting next to I-77 heading east, crossing Dueber Avenue and continuing east in DEO easements.

**Anticipated Project Schedule:** The construction of the pipeline is anticipated to begin in October 2017. DEO plans to place the line in-service by December 2017.

**Expedited Treatment:** DEO requests expedited treatment for this application, and will submit payment of \$2,000 in accordance with OAC Rule 4906-6-04(A)(2).
