AEP Ohio Transmission Company, Inc. (AEP Ohio Transco), an affiliate of AEP Ohio, is proposing to rebuild an electric transmission line in Belmont County known as the West Bellaire-Glencoe 138kV Transmission Line. On January 27, 2017, AEP Ohio Transco submitted a siting application to the Ohio Power Siting Board (OPSB) for the West Bellaire-Glencoe 138kV Transmission Rebuild Project. On August 18, 2017, AEP Ohio Transco submitted supplemental project information to the OPSB. In accordance with Ohio Administrative Code (OAC) 4906-3-06 (A)(1), the OPSB certified this application as complete on August 25, 2017.

Pursuant to OAC 4906-3-07, we are sending you one copy of the supplemental documentation, which is a part of the accepted, complete application. As required by the OPSB, the application includes information on justification of need, technical and financial data, and a socioeconomic and ecological analysis of the project. Pursuant to OAC 4906-2-12(A)(1), if you wish to intervene in this proceeding, you must file a notice of intervention with the OPSB within thirty (30) days of being served a copy of this Application.

We ask that this application be made available to the general public.
