DOMINION ENERGY OHIO'S SUPPLEMENT TO CONSTRUCTION NOTICE

On October 6, 2017, the Ohio Power Siting Board Staff issued its Staff Report, which contains the six conditions listed below:

- 1) Prior to the commencement of construction activities in areas that require permits or authorizations by federal or state laws and regulations, the Applicant shall obtain and comply with such permits or authorizations. The Applicant shall provide copies of permits and authorizations, including all supporting documentation, to Staff within seven days of issuance or receipt by the Applicant.
- 2) The Applicant shall adhere to seasonal cutting dates of October 1 through March 31 for removal of any trees greater than three inches in diameter, unless coordination efforts with the Ohio Department of Natural Resources (ODNR) and the U.S. Fish and Wildlife Service allows a different course of action.
- 3) The Applicant shall submit to Staff a traffic plan seven days prior to the start of construction. The traffic plan shall include, but not be limited to: maintain traffic along public roadways and adjacent land uses during construction; notify local government and emergency services of traffic and safety related issues.
- 4) The Applicant shall segregate soils during excavation activities involving the disturbance of top soil, and restore any disturbed area to original or better conditions. This condition may be waived with the consent of the property owner.
- 5) Where the pipeline route crosses driveways, parking areas, or roads the impacted areas shall be repaired promptly to their pre-construction state.
- Prior to construction, the Applicant shall submit to Staff, for review and confirmation that it complies with this condition, a project construction plan. The specific locations of its laydown areas and is responsive to ODNR concerns about state listed species and ecological areas of significance. If the specific laydown locations chosen appear to have additional adverse impacts, the Applicant shall either propose different specific locations without such impacts, or refile its application.

By this submission, Dominion Energy Ohio ("DEO") incorporates the above conditions as a supplement to its Construction Notice filed September 22, 2017, and requests that this supplement be considered part of DEO's application.
