- **¶ 1** This matter originally was scheduled for a hearing on October 12, 2017.
- {¶ 2} On October 5, 2017, Ohio Edison Company (Ohio Edison or Company) filed a stipulated motion for a continuance of the hearing date. In the motion, Ohio Edison states that Jack Campbell, Jeff Campbell, and Jeff Campbell, Jr. (Complainants), made a verbal request to counsel for Ohio Edison indicating that they need additional time to complete further discovery. Ohio Edison states that the Company has agreed to a continuance of this matter to allow for the completion of discovery and, accordingly, is filing this stipulated motion for a continuance. Ohio Edison and Complainants, therefore, request that the current hearing date in this matter be vacated and that the hearing be continued for approximately 40 days.
