**SUPPLEMENTAL INFORMATION  
IN SUPPORT OF APPLICATION**

---

On August 1, in accordance with R.C. 4933.25 and Ohio Adm. Code 4901:1-15-05, Aqua Ohio, Inc. (Aqua or the Company) filed its application in this case, seeking the issuance of a certificate of public convenience and necessity to authorize the provision of water and sewage-disposal service to the areas currently served by the Firestone Trace Homeowners' Association (the Association). Based on discussions with Staff, Aqua hereby files the following supplemental information in support of the application.

First, Aqua reiterates the statement in its original application concerning the establishment of rates to the residents of the Association. The rates were agreed upon by Aqua and the Association. That these rates are just and reasonable is evidenced by the fact that Aqua and the Association have mutually agreed to them. If the rates were not just and reasonable with respect to the Association and its residents, the representatives of the Association would not have executed the contract with Aqua. Accordingly, in accordance with R.C. 4909.18, Aqua requests that the Commission "permit the filing of the schedule proposed in the application and fix the time when such schedule shall take effect."

Additionally, the negotiated rates for water and sewage-disposal service are fair and reasonable to Aqua's existing customers because existing customers are not harmed nor are the rates of existing customers in any way subsidizing the costs of providing these services to the Association. The negotiated rates for water and sewage-disposal service with the Association, and the revenue anticipated from providing these services to the Association, will cover the costs of providing these services. Once the Association is being served under Commission-approved rates, there will be a benefit to all customers as the costs of service will be spread over a larger customer base.

Finally, Aqua's application made reference to notice that had already been provided to residents of the Association of the pending transfer of service. In addition to the open house event that was attended by Aqua, Aqua is attaching to this supplemental information a copy of a written notice that was provided to members of the Association regarding the transfer, which was also attended by representatives of Aqua.

For these reasons, and those reasons set forth in the original application, Aqua respectfully requests that the Commission approve the application and issue an order granting all necessary and proper relief.
