NOTICE OF PROPOSED MAJOR UTILITY FACILITY

Duke Energy Ohio proposes to construct approximately 0.27 miles of 138 kV transmission line between the planned East Provident Substation and the existing Duke 138kV transmission line located in in West Chester Township, Butler County, Ohio. The proposed project area consists of approximately 0.27 miles of new and existing 100-foot wide Duke Energy transmission line corridor Right-Of-Way (ROW), and includes the replacement of ten (10) structures. The Project begins at the proposed East Provident Substation located north of Provident Drive (39.31430, -84.45795), and terminates south of Provident Drive (39.31245, -84.45778) as it enters the existing Duke Energy right-of-way (ROW). The Project location and general layout are shown on the accompanying map.


