## MEMORANDUM IN SUPPORT

---

On March 2, 2017, Duke submitted an application for an increase in electric distribution rates, for approval of tariff modifications, and for approval to changes in certain accounting methods in the above-captioned proceeding. By entry dated November 14, 2017, the Commission adopted a procedural schedule setting a date for the filing of testimony and an evidentiary hearing as follows:

1. All pre-filed testimony is to be filed by November 29, 2017.
2. The evidentiary hearing is to begin on January 3, 2017 at 10:00 a.m.

For the reasons set forth below, Staff requests an extension of the procedural schedule which would amend the procedural schedule as follows:

1. All pre-filed testimony is to be filed by January 8, 2018.
2. The evidentiary hearing is to begin on January 22, 2018 at 10:00 a.m.

All of the parties have met to discuss settlement. Staff respectfully requests an extension as described above in order to facilitate continued settlement discussions and explore whether a partial or complete settlement may be reached. If a partial or complete Stipulation and Recommendation (“Stipulation”) is filed by two or more parties before January 22, 2018, then Staff requests that the Attorney Examiner further modify the above procedural schedule at that time in order to accommodate the preparation of

testimony in support of the Stipulation, possible preparation of testimony in opposition to the Stipulation, and the parties' preparation for hearing. If for some reason no Stipulation is filed prior to the rescheduled hearing date, the evidentiary hearing will commence with the first witness on January 22, 2018.

O.A.C. 4901-1-12(C) allows a party to request that the Commission consider a motion on an expedited basis. No party opposes either the motion or Staff's request for immediate ruling. Accordingly, Staff respectfully requests an expedited ruling for an extension of the procedural schedule.
