Staff requests that the Commission keep both the Report of the Commission Consultant Regarding AEP Ohio's November 2017 Standard Service Offer Auction and the Final Report of the Auction Manager, AEP Ohio CBP, dated November 28, 2017 confidential and that they not be publicly released. This information identifies the details of various bids and parties making the bids in the November 2017 Ohio Power auction. This information is highly competitively sensitive. Public disclosure of this information would be highly prejudicial to the bidding parties and to the viability of any future auction in Ohio.

Keeping this material confidential is consistent with the Commission's actions in prior auction matters. A redacted version of the Final Report of the Auction Manager, AEP Ohio CBP, dated November 28, 2017 has been filed publicly in this docket.
