AMENDMENT TO EXHIBIT A [Term Sheet]

Reference is hereby made to the Term Sheet filed with the Public Utilities Commission of Ohio (PUCO) on November 8, 2017 in Case No. 17-2321-GA-AIS as Exhibit A to the Application of the Suburban Natural Gas Company for Consent and Authority to Establish Long-Term Financial Arrangements (the "Term Sheet").

Under subsection "Other Conditions" of the Term Sheet, the second bullet point is hereby deleted and replaced with the following:

• Implementation of increased rate case applied for to PUCO by Suburban Natural Gas, indicating an increase in annual revenue to Suburban Natural Gas of at least \$1.5MM per annum by September 30, 2019. Bank hereby acknowledges that this condition does not bind the PUCO to approve a future rate increase request by Suburban Natural Gas at any particular revenue level.
