# FIRST AMENDMENT TO AGREEMENT FOR USE, REPAIR, AND IMPROVEMENTS OF ROADS

This First Amendment to Agreement for Use, Repair, and Improvements of Roads (this "First Amendment"), is made and entered into this \_\_\_\_\_\_ day of December, 2017 (the "First Amendment Effective Date") by and between Paulding County and Latty and Blue Creek Townships, all political subdivisions organized under the laws of the State of Ohio ("Local Parties"), and Trishe Wind Ohio, LLC, an Ohio limited liability company ("Developer"). Each of the Local Parties and Developer are sometimes referred to as a "Party" and collectively as the "Parties".

#### RECITALS:

- A. The Parties entered into that certain Agreement for Use, Repair, and Improvement of Roads on September 7<sup>th</sup>, 2016 (the "Agreement").
- B. Pursuant to the requirements of Section 2.2 of the Agreement, Developer has met with the Local Parties and desires to amend Exhibit B to the Agreement to add additional roads, bridges, ditches, culverts or other structures designated as "Heavy Haul Routes" under the Agreement. In such meeting, Developer identified for the Local Parties the segments of public roads for which Developer desires to include within the definition of Heavy Haul Routes. Engineering details regarding the proposed new road segments were included in Exhibit C (the "Pre-Construction Inspection Report") per the Agreement under Table 4.1 Pavement Test Sections of the report.
- C. The Local Parties have completed their engineering due diligence on the new road segments and have approved those road segments and new, additional Heavy Haul Routes, and the Parties desire to enter into this First Amendment to supplement <a href="Exhibit B">Exhibit B</a> to the Agreement by adding the new, additional road segments as Heavy Haul Routes, as further identified in this First Amendment.

#### AGREEMENT:

NOW, THEREFORE, in consideration of the promises and mutual agreements and covenants herein contained, the receipt and sufficiency of which the Parties hereby acknowledge, intending to be legally bound, hereby agree as follows:

- 1. <u>Capitalized Terms.</u> Capitalized terms used herein and not otherwise defined shall have the meaning given to them in the Agreement.
- 2. <u>Supplementation of Exhibit B</u>. In addition to the Heavy Haul Routes identified on Exhibit B to the Agreement, the following additional roads, bridges, ditches, culverts or other structures shall be deemed to be additions to Exhibit B to the Agreement and shall hereafter be considered to be within the definition of "Heavy Haul Routes" as provided in the Agreement, as amended by this First Amendment:

Blue Creek Township: Township Road 79 – From State Route 114 to Township Road 60. Covering approx. 1.5 miles.

Trishe Wind Ohio, LLC ("Applicant") is certified to construct a wind-powered electric generation facility in Paulding County, Ohio ("Project"), in accordance with the December 16, 2013 Opinion, Order, and Certificate ("Certificate") issued by the Ohio Power Siting Board ("OPSB"). The Certificate is subject to the 40 conditions set forth in the December 16, 2013 Order, as well as the 26 conditions set forth in the October 1, 2013 Supplement to the original application ("Supplement").

Condition 25 of the Supplement requires Applicant to execute an "Agreement for Use, Repair, and Improvement of Roads" with Paulding County prior to construction for OPSB Staff's review and acceptance.
