MEMORANDUM IN SUPPORT

On November 8, 2017, the Public Utilities Commission of Ohio ("Commission") issued a Finding and Order adopting amended rules for net energy metering in the State of Ohio. The Companies timely filed an Application for Rehearing on December 8, 2017. The Companies and AEP Ohio have timely submitted initial and reply comments, applications, and memoranda, and have participated extensively in every phase of this proceeding.
