Dear Ms. McNeal:

AEP Ohio Transmission Company, Inc. (“AEP Ohio Transco”) files this corrected pre-application notification letter for the above-referenced Project pursuant to Rule 4906-6-03(A) of the Ohio Administrative Code. Please disregard the pre-application notification letter previously filed in this docket, which contained incorrect information regarding the existing line that this Project will rebuild.

AEP Ohio Transco has identified the need to rebuild the existing Summerfield – Berne 138 kV Transmission Line, located in Marion Township, Noble County and Seneca and Franklin townships, Monroe County, Ohio to 138 kV. Rebuilding the existing line is necessary in order to accommodate projected increased load and provide more reliable service to AEP customers in the surrounding area. The existing 138 kV transmission line is approximately 3.5 miles in length and traverses between the Summerfield Substation, located in Marion Township, Noble County and the Berne Substation, located in Franklin Township, Monroe County, Ohio. The proposed Project is entirely along the existing transmission line right-of-way, and is the least impact and most cost-effective option to increase service reliability and accommodate projected load growth in the area.

AEP Ohio Transco anticipates that construction of the Project will begin in March 2018. The anticipated in-service date for the Project is approximately December 2018.

Please be advised that pursuant to O.A.C. 4906-6-04, AEP Ohio Transco is requesting an expedited review of this Project; however, AEP Ohio Transco would like to waive the expedited review period of 28 days set forth in Rule 4906-6-03(B) and instead requests that the processing time for this matter be expedited to 60 days after the date of filing. APE Ohio Transco will submit payment of \$2,000 in accordance with O.A.C. 4906-6-04(A)(2) on the date of filing.
