**DOMINION ENERGY OHIO'S
SECOND SUPPLEMENT TO CONSTRUCTION NOTICE**

On December 28, 2017, the Ohio Power Siting Board Staff issued its Staff Report, which contains the two conditions listed below:

- 1) Prior to the commencement of construction activities in areas that require permits or authorizations by federal or state laws and regulations, the Applicant shall obtain and comply with such permits or authorizations. The Applicant shall provide copies of permits and authorizations, including all supporting documentation, to Staff within seven days of issuance or receipt by the Applicant.
- 2) Prior to construction, the Applicant shall submit to Staff, for review and confirmation that it complies with this condition, a project construction plan which includes the specific locations of its laydown areas. If the specific locations chosen appear to have additional adverse impacts, the Applicant shall either propose different specific locations without such impacts, or refile its application.

By this submission, Dominion Energy Ohio ("DEO") incorporates the above conditions as the second supplement to its Construction Notice filed December 13, 2017, and requests that this second supplement be considered part of DEO's application.
