The proposed Lemaster-Strouds Run 138kV Transmission Line Rebuild Project Update, Public Utilities Commission of Ohio Case Number 17-2441-EL-BLN, consists of relocating a 138 kilovolt (kV) transmission line on property owned by AEP Ohio Transco. The total length of the Lemaster-Strounds Run transmission line relocation is less than a half mile long. AEP Ohio Transco will upgrade the transmission line by using primarily single pole, steel structures. This project will be an approximate \$1 million investment by AEP Ohio Transco. The project will traverse York Township in Athens County. Construction is scheduled to begin in March 2018.

In compliance with Rule 4906-6-01, et seq., of the OAC, we have prepared and filed a Letter of Notification with the OPSB. The Letter of Notification to construct, operate and maintain this facility is now pending before the board.


