{¶ 1} Staff served a notice of preliminary determination (NPD) upon Frontier Technology Corp (Respondent), in accordance with Ohio Adm.Code 4901:2-7-12, alleging a violation of the Commission's transportation regulations.

{¶ 2} On March 15, 2017, Respondent filed a request for an administrative hearing in the above-captioned case in accordance with Ohio Adm.Code 4901:2-7-13.

{¶ 3} A prehearing settlement conference was held on May 2, 2017; however, the parties were unable to settle this matter.

{¶ 4} By Entry issued November 2, 2017, the attorney examiner scheduled this matter for hearing on January 8, 2018.

{¶ 5} On January 5, 2018, Staff and Respondent filed a joint motion for continuance of the scheduled hearing date, indicating that they are still attempting to reach a settlement and need additional time to engage in settlement negotiations. The parties request that the hearing be continued to January 22, 2018.

{¶ 6} The attorney examiner finds that the joint motion for continuance is reasonable and should be granted. Accordingly, the evidentiary hearing for this matter shall be rescheduled for January 22, 2018, at 10:00 a.m., at the offices of the Commission, 180 East Broad Street, 11th Floor, Hearing Room 11-D, Columbus, Ohio 43215.

{¶ 7} It is, therefore,

{¶ 8} ORDERED, That the joint motion for continuance be granted and the hearing for this matter be rescheduled for January 22, 2018, in accordance with Paragraph 6. It is, further,

{¶ 9} ORDERED, That a copy of this Entry be served upon all parties of record.
