In accordance with Rules 4906 of the Ohio Administrative Code (OAC), AEP Ohio Transmission Company, Inc., (AEP Ohio Transco) is required to submit a Letter of Notification to the State of Ohio Power Siting Board (OPSB) when certain transmission facilities are constructed.

The proposed Devola Station Project, Public Utilities Commission of Ohio Case Number 18-0034-EL-BLN, consists of constructing a new 138-kilovolt substation. The approximate 4-acre substation will be built on property owned by AEP Ohio Transco.
