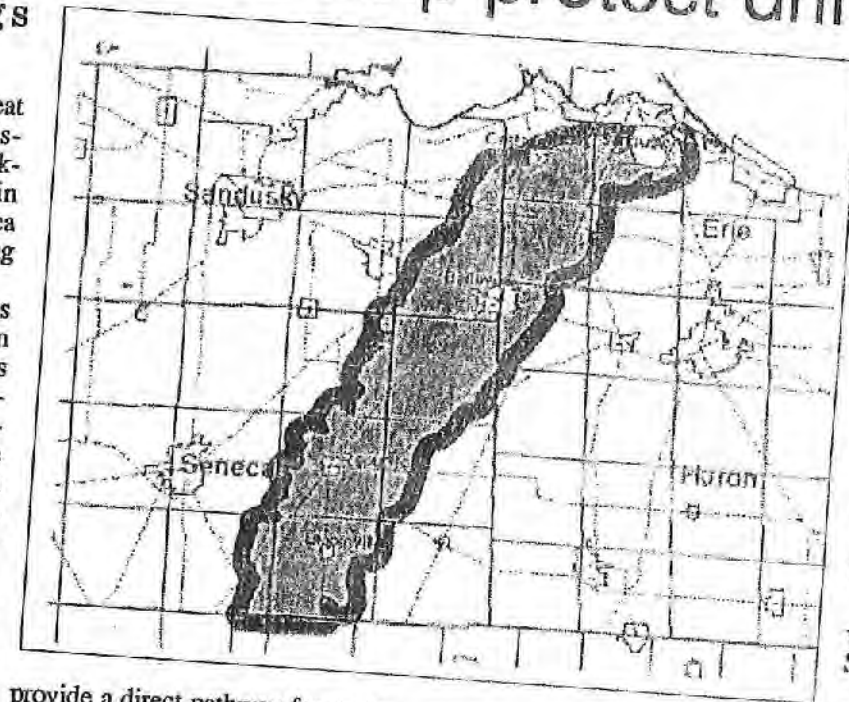
• Area meetings seek input

FREMONT— The WSOS Great Lakes Rural Community Assistance Program (GLRCAP) is seeking help from property owners in Sandusky, Erie, Huron and Seneca counties on how to protect drinking water in the four-county area.

GLRCAP has scheduled a series of meetings on March 15 to obtain input from local property owners on the best way to manage activities that have been identified as potential threats to groundwater in the area. The plan developed from these meetings is a part of the Ohio Source Water Assessment and Protection Program.

Residents in the following communities are encouraged to participate in the meetings since they are the ones mostly affected. They are, the eastern townships in Seneca County: Bloom, Scipio, Venice, Thompson, Clinton, Eden, Reed, and Adams; western townships in Erie County: Groton, Perkins, Oxford, Margaretta and Huron; the eastern townships in Sandusky County: Green Creek, Townsend and York; and the extreme western section of Huron County: Lyme and Sherman townships.

The potential for groundwater contamination in the areas called a karst region. Typical karst features include sinkholes, losing streams, caves and springs, all of which are inter-related. These openings can



provide a direct pathway for contamination to enter the groundwater, which rural residents and public water systems rely on for drinking water. If groundwater becomes contaminated, it can impact people's health and requires costly clean up.

GLRCAP has formed a stakeholder group of public water systems and other interested citizens and agencies (including soil and water, local farm bureaus, health departments, local officials, etc.) in the area, and has conducted several meetings to compile a potential pollution source inventory. Now that the inventory is complete, the

next step is to create a management plan, which will focus on educating the public on the vulnerability of the area as well as provide specific practices residents can cultivate to protect the groundwater supply.

To create that management plan, GLRCAP needs the assistance of area residents. Residents can provide that assistance by participating in the following meetings in the following areas:

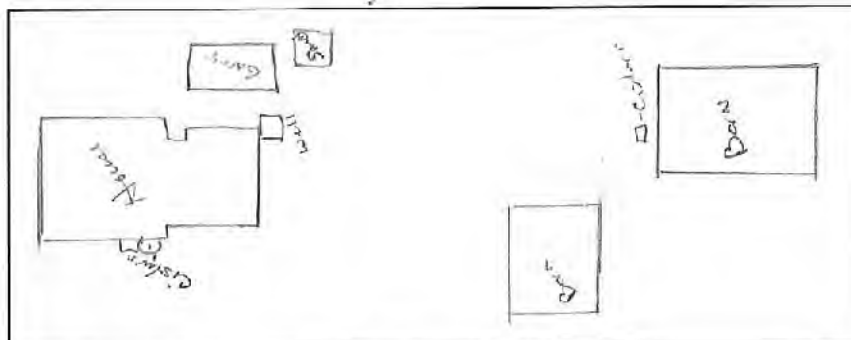

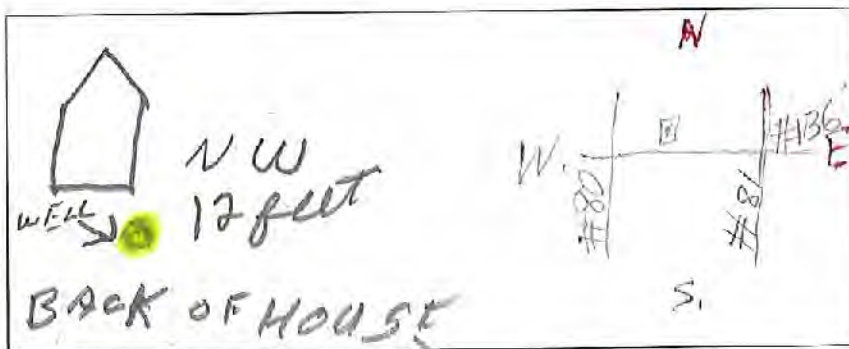
