## **ENTRY**

- {¶ 1} The Ohio Bell Telephone Company DBA AT&T Ohio (AT&T) is a telephone company as defined in R.C. 4927.01 and, as such, is subject to the jurisdiction of this Commission.
- {¶ 2} Pursuant to R.C. 4927.21, the Commission has authority to consider a complaint filed against a telephone company by any person regarding any rate, practice, or service of the company relating to any service furnished by the telephone company that is unjust, unreasonable, unjustly discriminatory, or in violation of, or noncompliance with any provision of R.C. 4927.01 to 4927.20, or a rule or order adopted or issued under those sections.
- {¶ 3} On December 26, 2017, Walter J. Skotynsky (Complainant) filed a complaint against AT&T. Complainant alleges that AT&T provided inadequate transfer of service from his former office location to his new office location.
  - $\{\P\ 4\}$  On January 16, 2018, AT&T Ohio filed an answer and a motion to dismiss.
- {¶ 5} On January 25, 2018, Complainant filed a motion of extension of time to respond to AT&T's motion to dismiss. In the motion, Complainant indicates that he recently had back surgery and is currently in physical therapy. Consequently, Complainant requests

until February 28, 2018, to file a memorandum contra to AT&T's motion to dismiss. AT&T did not oppose this request.

{¶ 6} Upon review, the attorney examiner finds that Complainant's request is reasonable due to the reasons stated. Consequently, the attorney examiner grants Complainant an extension until February 28, 2018, to file a memorandum contra to AT&T's motion to dismiss.

{¶ 8} ORDERED, That, in accordance with the above findings, Complainant should be granted an extension until February 28, 2018, to file his memorandum contra to AT&T's motion to dismiss. It is, further,
