Exhibit C

Description of the Transaction

Network Billing Systems, LLC ("NBS"), ¹ Fidelity Connect, LLC ("Fidelity Connect") and Fidelity Telecom, LLC ("Fidelity Telecom," and, together with NBS and Fidelity Connect, the "Applicants"), respectfully request Commission approval, insofar as required, for a *pro forma* intra-corporate transaction that will merge Fidelity Connect and Fidelity Telecom into NBS and, in so doing, transfer all of the assets and customers of Fidelity Connect and Fidelity Telecom to NBS (the "Reorganization"). Following consummation of the Reorganization, Fidelity Connect and Fidelity Telecom will cease to exist as legal entities. As discussed in greater detail below, the Reorganization is part of a larger intra-corporate merger of NBS and several lateral affiliates, all of which are wholly-owned subsidiaries of Fusion Telecommunications International, Inc. ("Fusion").² The Merger will simplify the corporate structure of the Fusion Companies' communications operations, with resulting benefits for current and future Fusion Companies customers.

The Applicants

The Fusion Companies provide digital voice and data communications services, including hosted Voice over Internet Protocol ("VoIP") and Session Initiated Protocol ("SIP") trunking, and other enhanced communications services and features to businesses primarily in the United States. The Fusion Companies also provide VoIP services to carriers worldwide.

Fusion is a publicly traded Delaware corporation (NASDAQ: FSNN), with its headquarters located at 420 Lexington Avenue, Suite 1718, New York, New York 10170. Fusion holds Section 214 authority from the Federal Communications Commission ("FCC") to provide interstate and international telecommunications services. Fusion does not hold authority to provide intrastate telecommunications services within any state.

Fusion's wholly-owned indirect subsidiary, NBS, is a New Jersey limited liability company with corporate headquarters located at 695 U.S. Route 46 West, Fairfield, New Jersey 07004. NBS provides Unified Communications and hosted voice and data services, broadband Internet access service, interconnected VoIP, data networks, and traditional voice solutions primarily to business customers throughout the United States. In Ohio, the Commission has authorized NBS to operate as an interexchange telecommunications service provider in Case No. 90-6129-TP-TRF pursuant to Certificate No. 90-6129; and as a local exchange provider in Case No. 11-1160-TP-ACE on April 25, 2011 pursuant to Certificate No. 90-9386. Additionally, NBS holds authority to offer intrastate telecommunications services in 46 other states. NBS also holds Section 214 authority from the FCC to provide interstate and international telecommunications services.

Fidelity Connect is an Ohio limited liability company, with principal offices located at 420 Lexington Avenue, Suite 1718, New York, New York 10170. Following its acquisition by a

Fusion subsidiary holding company in 2015,³ Fidelity Connect is an indirect wholly-owned subsidiary of Fusion. Fidelity Connect has been authorized by the Commission to provide competitive local exchange and competitive telecommunications services in Ohio pursuant to Certificate No. 90-9383 granted in Case No. 10-2349-TP-ACE. Fidelity Connect provides voice and data services, but does not currently provide basic local exchange services in Ohio.

Fidelity Telecom is an Ohio limited liability company, with principal offices located at 420 Lexington Avenue, Suite 1718, New York, New York 10170. Following its acquisition by a Fusion subsidiary holding company in 2016,⁴ Fidelity Telecom is an indirect wholly-owned subsidiary of Fusion. Fidelity Telecom has been authorized by the Commission to provide competitive local exchange and competitive telecommunications services in Ohio pursuant to Certificate No. 90-9373 granted in Case No. 09-0718-TP-ACE. Fidelity Telecom provides voice and data services, including basic local exchange services, in Ohio.

The Merger

In order to simplify its corporate structure, Fusion is undertaking a number of *pro forma* intracorporate transactions that will consolidate the operations of eight current wholly owned subsidiaries into NBS. NBS will be the surviving entity and Fidelity Connect, Fidelity Telecom and the other merging companies will cease to exist as separate corporate entities. Upon completion of the Reorganization, all of the Fusion intrastate business and cloud telecommunications services in Ohio will be provided through NBS. Diagrams illustrating the corporate organization of the Fusion Companies pre- and post-consolidation are appended.

The proposed Reorganization will have no adverse effect upon customers of Fidelity Connect and Fidelity Telecom. Each customer currently served by Fidelity Connect and Fidelity Telecom pre-close will continue to receive the same services, albeit from NBS, post-close without any change to the associated rates, terms and conditions of service. Towards this end, NBS proposes to adopt the current tariffs of Fidelity Connect and Fidelity Telecom. The same senior management directing NBS as has been overseeing the Fidelity Connect and Fidelity Telecom

operations, ensuring a seamless transition and continuity of strategic vision. Moreover, notice of the proposed Reorganization will be sent to all customers for Fidelity Connect's and Fidelity Telecom's regulated services at least fifteen (15) days prior to the consolidation, via U.S. mail or email (by consent). A sample of the notice is appended as **Exhibit D-1**.

Upon consummation of the Reorganization, Fidelity Connect and Fidelity Telecom will cease to provide services in Ohio and will cease to exist as separate legal entities. Applicants will submit prompt notice of consummation and request that, following receipt of this notice, the Commission cancel Fidelity Connect's and Fidelity Telecom's Ohio telecommunication authorities.

Public Interest Considerations

Applicants submit that the proposed Reorganization is consistent with and beneficial to the public interest. The streamlining of the Fusion Companies' corporate structure will enhance operating efficiencies and result in measurable cost savings, which, in turn, will enable the Fusion Companies to compete more effectively in Ohio and throughout the United States, to the ultimate benefit of consumers.

At the same time, the Reorganization holds no risks for consumers. The consolidation of operations will not result in any change to services or rates and the same management team that has so effectively steered the Fusion Companies in the past will continue to do so going forward.



Fusion Companies (Post-Close)


