Compliance with the Administrative Law Judge's February 20, 2018 Entry – Supplemented Exhibit M

Dear Ms. McNeal:

On February 15, 2018, the Ohio Power Siting Board ("OPSB") issued its Opinion, Order, and Certificate approving and adopting the stipulation and recommendation in this matter, and issuing a certificate to Hardin Solar Energy LLC ("Hardin Solar") for the construction, operation, and maintenance of a solar-powered electric generation facility in Hardin County, Ohio.

On February 20, 2018, the Administrative Law Judge ("ALJ") issued an entry granting, in part, and denying, in part, Hardin Solar's July 5, 2017 Motion for Protective Order. Specifically, the ALJ granted Hardin Solar's request for protection of the financial information contained in the narrative of the Application, but denied the request for protection of the information contained in Exhibits A, B, and C of the Application, as well as part of Exhibit M.

With regard to Exhibit M, in the February 20, 2018 entry, the ALJ directed Hardin Solar by March 2, 2018, to either file a public version of Exhibit M with only the policy numbers and certificate number redacted or file the alternative description of liability insurance. In compliance with the ALJ's ruling, at this time, Hardin Solar is filing the attached Revised Exhibit M with the policy numbers and certificate number redacted.

Hardin Solar also notes that the ALJ directed the Docketing Division of the OPSB to move Exhibits A, B, and C to the public docket 10 days after issuance of the entry. While Hardin Solar understands that the documents in Exhibits A and B, as well as vast majority of the documents in Exhibit C may be released into the public record as early as March 5, 2018, Hardin Solar respectfully requests that Exhibit C Item 5 not be released pending the Board's ruling on the interlocutory appeal filed on February 27, 2018.
