- {¶ 1} Pursuant to Ohio Adm.Code 4901:2-7-12, Staff served a notice of preliminary determination (NPD) upon US Power Express, LLC (Respondent) alleging violations of the Commission's transportation regulations.
- {¶ 2} On January 26, 2018, Respondent's owner and driver, Ulugbek Abdurazzakov, filed a request for an administrative hearing as contemplated by Ohio Adm.Code 4901:2-7-13. Mr. Abdurazzakov participated in a prehearing conference on March 1, 2018, but the case was not resolved.
- {¶ 3} Accordingly, the attorney examiner sets this case for hearing on Wednesday, April 18, 2018, at 10:00 a.m., in Hearing Room 11-C at the offices of the Commission, 180 East Broad Street, 11th Floor, Columbus, Ohio 43215-3793.
- {¶ 4} At the evidentiary hearing, Staff must prove that Respondent committed the violations alleged in the NPD by a preponderance of the evidence. Ohio Adm.Code 4901:2-7-20. Following Staff's presentation of the evidence, Respondent will have the opportunity to present testimony and other evidence supporting Respondent's contentions regarding the alleged violations.
- {¶ 5} Pursuant to Ohio Adm.Code 4901:2-7-14, a respondent who has requested an administrative hearing and fails to appear for the evidentiary hearing shall be in default. A respondent in default shall be deemed to have admitted the occurrence of the violations charged and to have waived all further right to contest liability for the forfeiture proposed in the NPD.
