On August 22, 2016, the Ohio Rail Development Commission (ORDC) authorized construction for Indiana & Ohio Railway (IORY) to install active warning devices at the following location:

Street	DOT#	County	Project
Camargo Road	151-350H	Hamilton County	Lights and Gates

On January 25, 2017, the Commission issued a Finding and Order approving the project and ordering completion by October 25, 2017. On October 3, 2017, IORY filed a request for a 30 day extension for Camargo Road. The contractor, Progress Rail, informed IORY that there was a delay in the delivery of the project materials. Staff supported the 30 day extension request.

The crossing project has been completed (see attached memo) and is in-service as follows:
