2. Condition 11, regarding the contents and submission of the complaint summary report.
3. Condition 16, regarding the Ohio Department of Transportation Office of Aviation requirements.
4. Condition 17, regarding the contents, timing, and submission of information related to aviation.
5. Condition 19, regarding the timing of submission of as-built coordinates and heights.
6. Condition 22, regarding the noise mitigation measures Applicant is to implement.
