INTERCONNECTION AGREEMENT BY AND BETWEEN

THE CHAMPAIGN TELEPHONE COPANY

AND

TELEPORT COMMUNICATIONS AMERICA, LLC

This Interconnection Agreement ("Agreement"), entered into this 26th day of March, 2018, is entered into by and between The Champaign Telephone Company ("Champaign") with offices at 126 Scioto Street, Urbana, Ohio 43078 and Teleport Communications America, LLC ("TCA"), with offices at 1 AT&T Way, Bedminster, NJ 07921 herein collectively, ("the Parties").

NOW THEREFORE, the Parties agree as follows:

1. CONDITIONS

1.1 The Agreement between the Parties shall consist of the same terms and conditions, unless otherwise noted within this agreement, of the previous Interconnection Agreement for the State of Ohio entered into by and between Champaign and Sprint Communications Company L.P., signed January 3, 2007 and effective January 3, 2007 ("Adopted Agreement"), amended as noted herein. The Adopted Agreement is attached as Appendix A.

2. TERM

2.1 This Agreement shall become effective the date that it is signed by both Parties ("Effective Date"), and will have an initial term of two (2) years and will remain in force pursuant to the terms and conditions as set forth in Section 3 ("Term of the Agreement") of the Adopted Agreement.

3. PARTIES

3.1 Teleport Communications America, LLC ("TCA") is hereby substituted in the Adopted Agreement for Sprint Communications Company L.P.. Champaign shall remain as the other Party to the Agreement.

4. GENERAL

- 4.1 Other than as set forth herein, the Adopted Agreement remains unchanged and in full force and effect. In the event of a conflict between the terms of the Adopted Agreement and this Agreement, this Agreement will control.
- 4.2 This Agreement, executed by authorized representatives of Champaign and TCA, is made a part of and incorporates the terms and conditions of this Agreement and the Adopted Agreement.

5. BILLING AND PAYMENT

Sections 6.1 & 6.2 from the Adopted Agreement shall be replaced in their entirety with the following:

5.1 In consideration of the Services provided pursuant to this Agreement that are not tariffed services, TCA shall pay in immediately available funds the charges set forth in the Pricing Attachment. To the extent that TCA purchases tariffed services this Agreement shall not apply. Invoices with charges set forth in this Agreement shall be sent to:

5.2 A monthly billing statement for services rendered under this Agreement shall be prepared by both Parties and will reflect the calculation of reciprocal compensation due each Party. Payments for all bills will be due ninety (90) days after the bill date and are payable in immediately available funds. If such payment date would cause payment to be due on a Saturday, Sunday or Legal Holiday, payment for such bills will be due on the first business day following the Saturday, Sunday or Legal Holiday. If such bills are not received at least twenty (20) days prior to the payment due date, then the bill(s) shall be considered delayed. When a bill has been delayed, the due date will be extended by the number of days the bill was delayed, upon request of the receiving Party.

6. NOTICES

Section 14 from the Adopted Agreement shall be replaced in its entirety with the following:

7. NETWORK INTERCONNECTION METHODS

Section 1.1 within the Interconnection Attachment from the Adopted Agreement shall be replaced in its entirety with the following:

The Parties will provision two-way interconnection facilities for the delivery of Local Traffic and IntraLATA Toll Traffic to the meet point. The interconnection must be at least equal in quality to that provided by CHAMPAIGN to itself or to any subsidiary, Affiliate, or any third party to which CHAMPAIGN provides interconnection. CHAMPAIGN shall provide interconnection on rates, terms and conditions that are just, reasonable and nondiscriminatory in accordance with the terms and conditions of this Agreement and the requirements of the Act.

8. INTERCONNECTION TRUNKING ARRANGEMENTS:

Section 5.1.1 within the Interconnection Attachment from the Adopted Agreement shall be replaced in its entirety with the following:

The Parties will establish two-way trunk groups where technically feasible, to exchange Local Traffic and IntraLATA Toll Traffic.

9. TRUNK SERVICING

Section 9.3 within the Interconnection Attachment from the Adopted Agreement shall be replaced in its entirety with the following:

9.3 Orders to establish, add, change or disconnect trunks shall be processed by using Access Service Requests, trunk orders, or other mutually acceptable means (collectively referred to hereafter as "ASRs"). TCA will issue ASRs for two way trunk groups for traffic that originates in TCA and terminates to CHAMPAIGN. The Parties agree that neither Party shall alter trunk sizing without first conferring with the other Party.
