I. SUMMARY

{¶ 1} The Commission finds that Mitchell Heim's request to withdraw its original application and cancel Certificate No. 12-SPV-PA-GATS-0665 is reasonable and should be granted.

II. DISCUSSION

{¶ 2} On February 15, 2012, Mitchell Heim filed an application for the certification of Heim-Mitchell-PA-PV-5.52kW Residence as an eligible Ohio renewable energy resource generating facility. The application was approved and the Commission issued Certificate No. 12-SPV-PA-GATS-0665 for the facility on April 16, 2012.

{¶ 3} On September 13, 2016, Mitchell Heim filed a request to withdraw the original application filed and cancel the certificate issued in this proceeding, explaining that the facility has already been certified in Case No. 13-486-EL-REN.

(¶ 4) Staff also filed its Review and Recommendation on September 13, 2016, confirming that the facility is also certified in Case No. 13-486-EL-REN. Moreover, Staff notes that the certificate number granted in Case No. 13-486-EL-REN is the certificate number registered with the Generation Attribute Tracking System. Thus, Staff recommends that the Commission revoke Certificate No. 12-SPV-PA-GATS-0665.

{¶ 5} The Commission agrees with Staff's recommendation and finds that Mitchell Heim's request to withdraw the original application and cancel Certificate No. 12-SPV-PA-GATS-0665 is reasonable and should be granted.
