ALJ AGRANOFF: The Ohio Power
Siting Board has assigned for adjudicatory
hearing at this time and place Case No.
17-1189-EL-BGN which is captioned In the Matter
of the Application of Harrison Power LLC for a
Certificate of Environmental Compatibility and
Public Need for an Electric Generating Facility
in Harrison County, Ohio.

My name is Jay Agranoff, and I am
Administrative Law Judge assigned by the Ohio
Power Siting Board to preside over this
adjudicatory hearing.

Pursuant to the entry of January
25th, 2018 a public hearing in this proceeding
took place on April 5th, 2018 in Cadiz, Ohio.

The entry also scheduled a
adjudicatory hearing for today, April 16th, 2018
taking place at the offices of the Ohio Power
Siting Board.

I would also note that on April 6th,
2018 Harrison Power filed a motion for an
extension of deadlines. This motion was granted

pursuant to the entry of April 11th, 2018.

At this time we will take
appearances. On behalf of the Applicant.

MR. SETTINERI: Thank you, Your
Honor. On behalf of Harrison Power LLC, Michael
Settineri with the law firm of Vorys, Sater,
Seymour and Pease, 52 East Gay Street, Columbus,
Ohio.

ALJ AGRANOFF: Thank you. And on
behalf of the Staff of the Ohio Power Siting
Board.

MR. JONES: Yes. Good morning, Your
Honor. On behalf of the Staff of the Ohio
Power Siting Board, Ohio Attorney General Mike
Dewine, Assistant Attorney General John Jones,
30 East Broad Street, Columbus, Ohio 43215.

ALJ AGRANOFF: Thank you. Let
the record reflect also that Hess Ohio
Development LLC and CNX Gas Company LLC as well
as the Community Improvement Corporation of
Harrison County were each granted intervention
in this proceeding. I do not see counsel for
either of the entities here today. But, they
are parties to this particular proceeding.

At this point in time would either

1 of the counsel that are in attendance this
2 morning care to give me an update as to where we
3 stand relative to the schedule in this
4 proceeding?

5 MR. SETTINERI: I will go ahead
6 first, Your Honor, if you would like. At this
7 time with the extentions being granted we remain
8 on track to satisfy those deadlines.

9 And as well if there is a
10 stipulation reached by the parties it would be
11 filed by May 4th pursuant to your entry.

12 ALJ AGRANOFF: And does the Staff
13 concur with that representation?

14 MR. JONES: Yes, Your Honor. The
15 Staff would concur with that representation.

16 ALJ AGRANOFF: Thank you. And are
17 counsel aware of the acquiescence of those
18 agreements with the intervenors in this
19 proceeding as well?

20 MR. SETTINERI: I would anticipate
21 any stipulation filed in the matter would
22 address any and all concerns in the proceeding
23 would be the goal. I hope that answers your
24 question.

25 ALJ AGRANOFF: If you can repeat

1 your response.

2 MR. SETTINERI: Sure. I would
3 anticipate any stipulation entered in the
4 proceeding would address any issues of all the
5 intervenors as is typical in these proceedings.

6 ALJ AGRANOFF: Okay. Thank you. Is
7 there anything further?

8 MR. JONES: No, Your Honor.

9 ALJ AGRANOFF: Thank you. If not
10 then we will reconvene on May 8th, 2018 at 10:00
11 A.M. in Hearing Room 11 A. Thank you.
