#### **MEMORANDUM IN SUPPORT**

Pursuant to Rule 4901:2-7-12, Ohio Adm. Code, the Staff served Shawn Lewis ("Respondent") with a Notice of Preliminary Determination (NPD) regarding the Respondent's failure to use a seat belt while operating a commercial motor vehicle in violation of 49 C.F.R. § 392.16. Staff intended to assess a \$100 forfeiture for the violation as noticed in the NPD. On February 5, 2018, Respondent filed a request for an Administrative Hearing. On March 19, 2018, the Attorney Examiner issued an Entry scheduling this matter for hearing on May 10, 2018. On May 2, 2018 Respondent made full payment of the \$100 forfeiture that Staff requested in the NPD. After payment was received by the Public Utilities Commission of Ohio (Commission), Counsel for Staff contacted Respondent who confirmed he did not want to continue the proceedings in this case and stated that his payment resolved this matter in full. Likewise, Rule 4901:2-7-22, Ohio Adm. Code, provides that full payment constitutes an admission to the violation and shall terminate further proceedings.

Accordingly, Staff requests that the Commission terminate any further proceedings due to Respondent's full payment of the forfeiture that was assessed by Staff in the NPD.
