Lighthouse Power Partners, LLC ("Lighthouse") was issued its Certificate No. 16-1609E by the Public Utilities Commission of Ohio in May of 2016 in Case No. 16-661-EL-AGG. Limited efforts were made to market services in 2016, and no customers were contracted during that calendar year.

Lighthouse converted to a single-member partnership entity and revised its strategy to primarily focus to renewable energy and energy efficiency in 2017. The owner of Lighthouse was retained to assist in the development of a solar power provider in Georgia, and spent material time out of the state managing the duties of that assignment.

As Lighthouse realized no revenue relating to the business of being a power broker or aggregator in Ohio in 2016, Lighthouse was of the impression that there was no obligation to file a 2016 Annual Report. Due to that impression and the out-of-state business obligations, it did not file a 2016 Annual Report. Lighthouse has since corrected the mistaken understanding that led to this failure, and has filed a 2017 Annual Report. Commission staff has requested that the motion attached to this Memorandum be approved by the Commission prior to the filing of a 2016 Annual Report. Upon such approval, Lighthouse will immediately file a 2016 Annual Report showing \$0 in revenue and 0 MWh in services provided in 2016.

Lighthouse deeply regrets is failure to understand the requirements and the resulting delay in filing, and respectfully requests that the Commission grant its motion for waiver and permit the filing of a 2016 Annual Report showing no revenue in 2016.
