{¶ 1} SJA Transport Inc. filed a request for hearing on March 16, 2017, and May 5, 2017, respectively, in the above-captioned cases.

{¶ 2} Prehearing conferences were conducted on May 11, 2017, and September 8, 2017, respectively. The parties participated in both conferences, but the matters were not resolved.

{¶ 3} An Entry was issued on September 11, 2017, scheduling a November 15, 2017 hearing for both cases. At SJA's request, a November 3, 2017 motion for continuance was granted on November 9, 2017. Subsequent continuance requests by both parties resulted in the hearing ultimately being conducted on April 23, 2018. At the hearing, deadlines for filing briefs and reply briefs were agreed upon, so that briefs must be filed by June 4, 2018, while reply briefs must be filed by June 25, 2018.

{¶ 4} On May 25, 2018, SJA filed a motion for extension of time to file briefs and reply briefs. SJA indicated that the parties have jointly agreed to file briefs by June 11, 2018, and reply briefs by July 2, 2018.

{¶ 5} The attorney examiner finds SJA's request to extend the date for filing briefs and reply briefs to be reasonable. Therefore, the motion is granted, and briefs shall be filed by June 11, 2018, while reply briefs shall be filed by July 2, 2018.
