MOTION FOR EXTENSION

Pursuant to Ohio Administrative Code Rule 4901:1-27-09(B), Good Energy L.P. (“Good Energy”) seeks an extension of Certificate No. 16-511G(1), which was issued in Case No. 16-0716-GA-AGG with an expiration date of May 5, 2018. Due to the press of other business, Good Energy was not able to file its renewal application on time. It filed its renewal application on April 30, 2018, which was five calendar days prior to the May 5, 2018 expiration date. In support of the application, Good Energy respectfully requests that Certificate No. 16-511G(1) be automatically extended from May 5, 2018 until June 5, 2018 or until the date that the renewal certificate is issued.

WHEREFORE, Good Energy respectfully requests that Certificate No. 16-511G(1) be automatically extended to June 5, 2018 or until a renewal certificate is issued and authorize it to continue to operate during the pendency of the renewal application certification review.

**MEMORANDUM IN SUPPORT OF
MOTION FOR EXTENSION**

Due to the press of other business, Good Energy did not meet the April 5, 2018 filing date for its Renewal Application in Case No. 16-0716-GA-AGG. Good Energy sincerely apologizes for the delay and emphasizes its desire to continue to serve customers in Ohio. Along with the Renewal Application, Good Energy also prepared a motion for extension but that motion was inadvertently not included in the material that was delivered to docketing. Good Energy is filing that motion as it intended previously to allow for the extension during the renewal review, which is ongoing.

Ohio Administrative Code Rule 4901:1-27-09(B) provides that a motion requesting an extension of a certificate will be deemed automatically approved (unless ruled otherwise by the Commission or an Attorney Examiner within three business days), if a renewal application is filed fewer than thirty calendar days prior to the expiration date of the certificate but no later than the expiration date. Good Energy submits that it has met the criteria and respectfully requests an automatic extension of the expiration date of Certificate No. 16-511(G)(1) issued in Case No. 16-0716-GA-AGG to June 5, 2018, or until such time as a renewal certificate is issued.
