Dear Attorney Examiners:

On May 4, 2018, Ohio Power Company (AEP Ohio) filed its compliance tariffs consistent with the Commission's Opinion and Order dated April 25, 2018 in Case Nos. 16-1852-EL-SSO and 16-1853-EL-AAM (Opinion and Order). On May 8, 2018, the Company supplemented the tariff compliance filing with revised tariffs. And on May 23, 2018, the Commission issued an Entry approving the revised compliance tariffs.

Separately, the Company had filed compliance tariffs on May 7, 2018 in Case No. 17-1083-EL-RDR (Storm Damage Recovery Rider) and filed proposed tariffs in Case No. 18-783-EL-RDR (updating its gridSMART Phase 2 Rider rates), which would be automatically approved today. Due to this overlapping period of compliance tariff approvals, the revised compliance tariffs in Case Nos. 16-1852-EL-SSO et al. did not include the updated rider rates for the SDRR or the gridSMART Phase 2 Rider.

The Company would like to ensure that the record is clear in all of the affected cases and is hereby submitting final compliance tariffs for the SDRR and the gridSMART Phase 2 Rider. The enclosed tariffs are identical to the revised compliance tariffs in Case Nos. 16-1852-EL-SSO et al., except the rider rates are updated to conform to

the outcome in Case Nos. 17-1083-EL-RDR and 18-783-EL-RDR and the tariffs reflect today's date as the issuance date. The Company will update its tariffs previously filed electronically with the Commission's Docketing Division.
