Dear Ohio Power Siting Board,

I am writing you to declare publicly my support for the Icebreaker Windpower project. I have been involved with this project since joining the Board of LEEDCo in 2013 as Secretary to the Board. Previous to my Board engagement, I was well informed of the project through my work at the City of Cleveland in the Office of Sustainability and through my work as an attorney with the Public Utilities Department.

This project has had nine lives. It has been through so many different iterations and paths and yet it still stands and is moving forward. I believe it has continued to move forward because the merits of the project are so strong. The possibility of wind generation in the fresh water of the Great Lakes would be unprecedented. The boost to local manufacturing in Ohio and the opportunity to grow a modern-day workforce based on skilled manufacturing and clean energy are opportunities we cannot afford to lose. By creating the first fresh-water wind farm in the United States, our state will be considered a leader and it will spur economic growth and engender goodwill for our state.

Regarding the environmental impact of the project, I can attest to the due diligence that the staff and consultants of LEEDCo have done to ensure the environmental impact of this project is greatly minimized. Specific to the issues of birds and migratory patterns found across the Great Lakes, the fact that we are only talking about six turbines as a demonstration project cannot even compare to the loses we face with birds flying into the large buildings in downtown Cleveland and along the lakefront. The studies have shown birds are not disproportionately harmed by turbines and LEEDCo will follow all best practices to ensure that birds and other animals are not greatly impacted by this work. The alternative created by dirty energy sources and the pollution they create for our wildlife cannot be forgotten.

Finally, in today's political climate where one side of the aisle does not work with let alone speak with the other side, this project has maintained bipartisan support and enthusiasm at all levels of government. This should not be taken lightly and should be considered in moving forward.
