I am writing to let you know about a public information meeting scheduled for 6:00-8:00 p.m. on Monday, July 9, 2018, about a proposed solar energy project in your area. The meeting will be held at the Concord Township Meeting Hall, which is located at 2281 State Route 136, Hillsboro, Ohio, 45133. The meeting is open to the public and will provide information about the Willowbrook Solar Farm. Willowbrook Solar I, LLC, an affiliate of Open Road Renewables, LLC, is proposing to build the Willowbrook Solar Farm, which will be a 150-megawatt solar electric generating project about two miles east of Mowrystown.

Following the public information meeting, Willowbrook Solar I, LLC plans to file an application for a Certificate of Environmental Compatibility and Public Need for the project with the Ohio Power Siting Board ("OPSB"). The staff of the OPSB will then review and investigate the application and will issue a report with recommendations. An evidentiary hearing will be scheduled before an Administrative Law Judge and a local public hearing will also be scheduled. Following the evidentiary hearing, the OPSB will issue a written decision. If you want to file a motion to intervene or file comments in this proceeding, you may do so by sending them to the OPSB at its address below and referencing OPSB Case No. 18-1024-EL-BGN.
