Dear Ms. McNeal:

Trishe Wind Ohio, LLC ("Applicant") is certified to construct a wind-powered electric generation facility in Paulding County, Ohio, in accordance with the December 16, 2013 Opinion, Order, and Certificate ("Certificate") issued by the Ohio Power Siting Board ("OPSB").

On January 25, 2018, the Applicant filed a letter notifying the OPSB of an update to the civil plan for the access road to Turbine 45 in accordance with Condition 6 to the Certificate. At this time, the Applicant is notifying the OPSB that there has been a further unsubstantial change to the access road for Turbine 45, due to a request from the landowner. Attached is a letter from the landowner explaining his request (Attachment 1), as well as aerial photos before (Attachment 2) and after (Attachment 3) construction of Turbine 45, which depict the location of the access road for Turbine 45. In addition, the Applicant notes that no new property owners are impacted as a result of this update.



RE: Request Movement of T-45 Access Road

In the past few years, GKS Farms, LLC has expanded our hog farm operations and built another hog barn that connects to our existing buildings. We were unaware that the new building actually shortened the distance between our daily operations and the developers permitted plans for the T-45 access road. Construction of the wind farm started in November 2017 and GKS Farms made request to Trishe Wind Ohio to move the proposed access road farther west and away from our hog operation. This was requested due to our new bio-security measures to prevent the spread of the PRRS virus which is major threat to any hog operations. Trishe Wind Ohio agreed to move the access road and was able to use existing farming lane which provided enough space per our bio-security guidelines. The area used for the road is the same area that was previously disturbed and used to support construction of the new barn.
