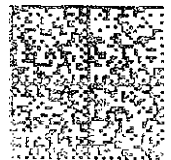

Dear Fidelity Telecom, LLC,

This is a notice from the Public Utilities Commission of Ohio (PUCO) that our records indicate Certificate ID# 90-9373 has not submitted their 2017 telephone relay service reporting form. **You have 10 days left and a civil forfeiture may be assessed for non-compliance.** The Commission has ordered you to file your TRS reporting form by July 20, 2018 and directed that a civil forfeiture may be assessed against those companies who fail to file, pursuant R.C. 4905.84. (Case No. 08-815-TP-ORD, finding and order, June 20, 2018).

Companies must register to gain access to the PUCO Community and file the 2017 TRS reporting form. Please call (614) 466-6904 to register.
