WHEREAS, the Board of Trustees of York Township has been informed that an application has been filed with the Ohio Power Siting Board relative to the Republic Wind, LLC alternative energy project; and

WHEREAS, the Board has determined that it is necessary to intervene to protect the interests of York Township; and

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF
YORK TOWNSHIP, SANDUSKY COUNTY, AND STATE OF OHIO:**

SECTION 1. That the Board has determined that it is necessary to intervene in the application of Republic Wind, LLC which is currently before the Ohio Power Siting Board based on all considerations as set forth in the Revised Code and Administrative Code.
