County Aggregation Program


Dear County Commissioners and County Representatives:

Pursuant to R.C. 4928.20 and the ballot initiative approved on May 4, 2010, Weller Township ("Township") has decided to conduct governmental aggregation on its own. Therefore, the Township hereby notifies Richland County ("the County") of its intent to not renew its participation in the County's Aggregation Program and to withdraw from the Aggregation Group as a member of the County Aggregation Group, effective at the conclusion of the current Power Supply Agreement with the County's Retail Electric Generation Provider, FirstEnergy Solutions, Inc. (FES). The Power Supply Agreement is scheduled to terminate at the end of nine years, which is in May 2019. Accordingly, Weller Township will not be participating in any subsequent County Aggregation Programs.

Please notify me of the exact end date of the Power Supply Agreement with FES and scheduled supply by FES so that we may coordinate the transfer of customer accounts to a new aggregation program and certified retail electric supplier in an orderly fashion.
