**Re:** PUCO Case No. 17-2199-RR-FED- In the Matter of an Extension Request for an Upgrade to the Active Warning Devices at the Norfolk Southern Railway Crossing, S. Munson Road DOT#509-484C, in Fulton County, Ohio.

On August 24, 2016, the Ohio Rail Development Commission (ORDC) authorized funding for Norfolk Southern Railway to upgrade the active warning devices at S. Munson Road DOT#509-484C, in Fulton County, Ohio. The crossing was surveyed on April 13, 2016 and found to warrant the upgrades.

On November 21, 2017, the Commission approved the project and ordered completion by August 21, 2018.

On August 7, 2018, NS filed for an extension until December 31, 2020. On August 17, 2018, NS filed an amended request for an extension until November 15, 2018. In the request, NS states that they are working to complete PTC (Positive Train Control) projects and their resources are being used to meet the federal mandate of December 31, 2018 for PTC.

ORDC has indicated to Staff that they not opposed to the extension request, but notes that this is a safety project.

Staff recommends that the Commission grant the 90 day extension request, but would like NS to complete the project by November 15, 2018. Staff will not consider additional extensions of time, due to PTC, unless firm and reasonable construction deadlines are provided.

## **MEMORANDUM IN SUPPORT**

By Finding and Order of November 21, 2017, the Commission authorized NSRC to install new active warning devices at the above-referenced grade crossing in the Village of Swanton, Fulton County. Substantial progress has been made – specifically, from a design and engineering standpoint, the project has been progressed as far as it can be. But with respect to actual construction and cut-in, NSRC seeks a deferral of the assigned project completion deadline. The reason is that NSRC – like a number of other rail carriers throughout the country – is obligated to comply with the Positive Train Control Enforcement and Implementation Act of 2015 ("PTC"), which carries with it what appears to be a firm installation deadline of December 31, 2018, with operational implementation to be accomplished no later than December 31, 2020.

This federal mandate – unprecedented in scope, as to both capital investment and requisite manpower – has caused the affected carriers, including NSRC, to mobilize/dedicate their resources (manpower and equipment), toward complying with the federal mandate.

In light of same, NSRC respectfully requests that the project completion deadline for the Swanton crossing be extended for ninety (90) days from the date of today's filing – so through November 15, 2018.
