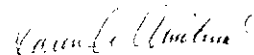
PROOF OF NOTICE OF PUBLIC INFORMATIONAL MEETING

Re: Public Information Meeting for the Highland Solar Farm

Dear [REDACTED]:

I am writing to let you know about a public information meeting scheduled for 6:00 p.m. to 8:00 p.m. on Monday, September 17, 2018, about a proposed solar energy project in your area. The meeting will be held at the Whiteoak High School within the Student Activity Center located at 44 N High Street, Mowrystown, Ohio 45155. The meeting is open to the public and will provide information about the Highland Solar Farm. Hecate Energy Highland LLC is proposing to build the Highland Solar Farm, which will be a 300-megawatt solar electric generation project developed over an area of approximately 2,500 acres currently containing agricultural land (row-crops).

Following the public information meeting, Hecate Energy Highland LLC plans to file an application for a Certificate of Environmental Compatibility and Public Need for the project with the Ohio Power Siting Board ("OPSB"). The staff of the OPSB will then review and investigate the application and will issue a report with recommendations. An evidentiary hearing will be scheduled before an Administrative Law Judge and a local public hearing will also be scheduled. Following the evidentiary hearing, the OPSB will issue a written decision. If you wish to file a motion to intervene or file comments in this proceeding, you may do so by sending them to the OPSB at its address below and referencing the OPSB Case No. 18-1334-EL-BGN.
