AMEND ITS ANNUAL REPORT FOR CALENDAR YEAR 2017

AEP Energy, Inc. ("AEP Energy") is authorized to provide electric marketer, power broker, and aggregation services in this state pursuant to Certificate No. 10-206E(5), which was issued by the Commission on April 24, 2018 in Case No. 10-384-EL-CRS.

Pursuant to the Commission's Entry in this docket, AEP Energy filed its annual report for calendar year 2017 on May 29, 2018 in this docket. However, as the result of a recent internal review, AEP Energy has determined that it incorrectly reported its 2017 gross receipts. In AEP Energy's original filing of the PUCO Annual Report for Fiscal Assessments for the year ending December 31, 2017, AEP Energy, Inc. reported an amount as its Statement of Intrastate Gross Earnings (Revenue) where the generation supplier is taking title to the power. AEP Energy erroneously arrived at these figures by reporting and adding together the Brokers and Aggregators revenue amounts, where the brokers and aggregators do not take title to the power. AEP Energy should have reported half of such amount as electric revenues. As a result, the PUCO and OCC assessments are twice the amount of what they should have been. Accordingly, by this application, AEP Energy requests leave to amend its 2017 annual report to correct this error and respectfully requests that the Commission authorize AEP Energy to submit updated reports in lieu of those filed on May 29, 2018.

Upon approval of its application, AEP Energy will make arrangements with the Commission's Fiscal Office to submit the amended annual report electronically through the Commission's web-based filing system for submitting annual reports.

AEP Energy recognizes that the change in the reported 2017 gross receipts will reduce the amount of the PUCO and OCC maintenance assessments due November 1, 2018. AEP Energy will promptly remit the adjusted amounts owed as determined by the Commission's Fiscal Office.

WHEREFORE, AEP Energy respectfully requests that its application to amend its 2017 annual report be granted.
