Dear Ms. McNeal:

Pursuant to Ohio Administrative Code Rule 4906-6-11(D), on October 3, 2018, NGO Transmission, Inc. ("NGOT") notified the Ohio Power Siting Board ("OPSB") that construction for the James Parkway Pipeline Replacement Project (Line 3-F), City of Heath, Licking County, Ohio was completed and in service as of September 26, 2018.

NGOT submits this revised construction notification to inform the OPSB that due to an engineering change, the final portion of the pipeline installation route was revised from the original filing as shown on the map attached hereto as Exhibit A.

The route variation resulted in no additional burdens or damages to the property and was installed under an existing easement. In addition, only scrub brush was cut and removed during installation. Archaeological monitoring was conducted during construction of the new route. As indicated in the report filed October 3, 2018, and the attached concurrence letter from the Ohio Historic Preservation Office, the project, with the revised pipeline route, will not affect historical properties.

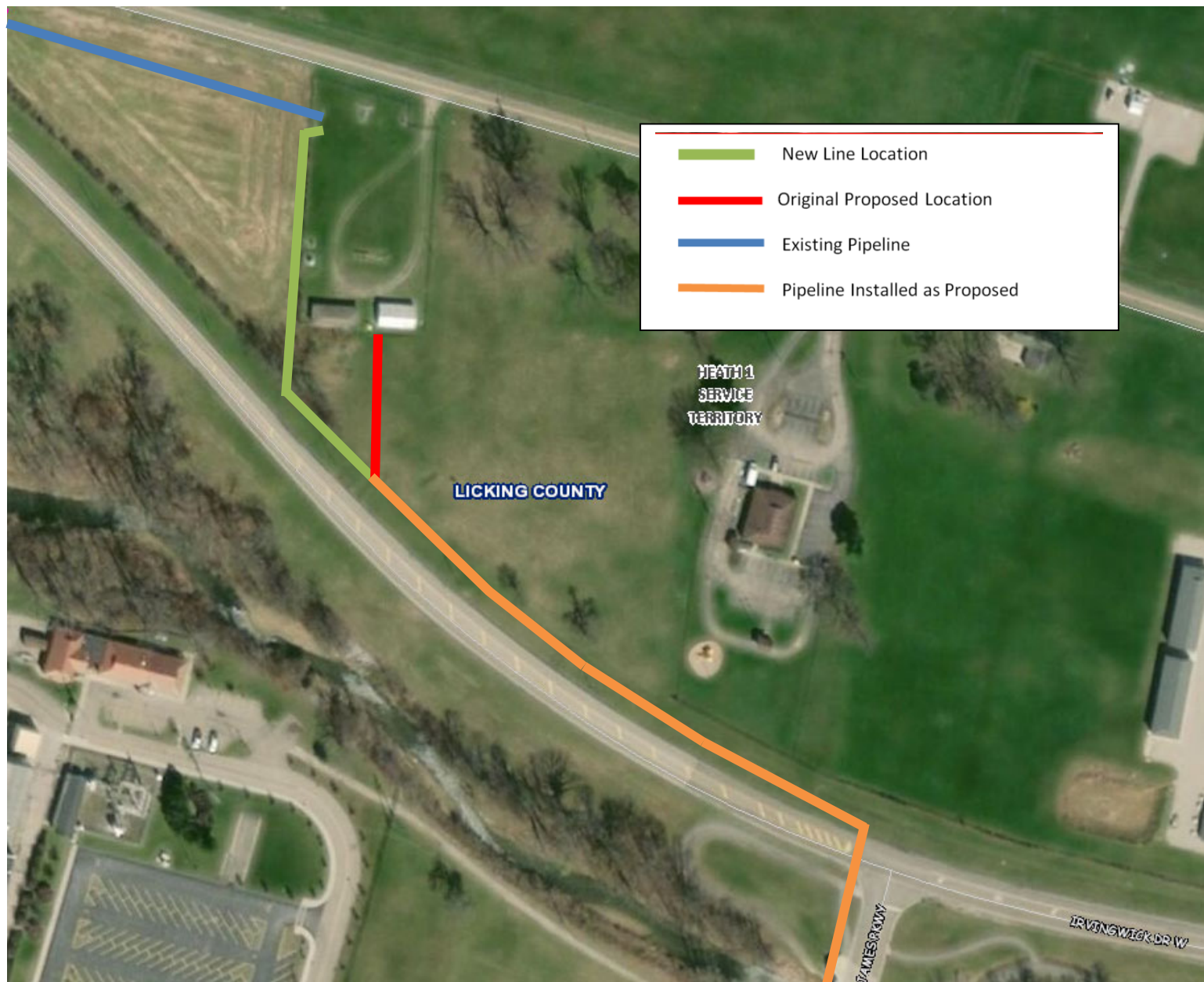

This is in response to the receipt, on October 2, 2018, of *Archaeological Monitoring of the James Parkway Gas Line Relocation North of Ramp Creek, City of Heath, Licking County, Ohio*. The comments of the Ohio Historic Preservation Office are submitted in accordance with the provisions of Section 106 of the National Historic Preservation Act of 1966, as amended.

Subsurface testing failed to identify any previously unrecorded archaeological sites. Therefore, based on the information provided, I agree with the recommendation that no further archaeological work is necessary in the proposed project area. It is my opinion that the proposed project will not affect historic properties. No further coordination is required unless the project changes or archaeological remains are discovered during the course of the project. In such a situation, this office should be contacted as per 36 CFR 800.13.
