Dear Ms. McNeal:

On October 15, 2018 the Company filed its compliance tariffs in this docket. These compliance tariffs have three components: (1) an update to the Pilot Throughput Balancing Adjustment Rider (PTBAR) to reflect a \$48.2 million one-time offset to the PTBAR's current under-recovery, (2) establishment of an initial level of the Tax Savings Credit Rider (TSCR) rate, and (3) to update the Distribution Investment Rider (DIR) in accordance with the Stipulation. The Finding and Order authorized AEP Ohio to file final compliance tariffs consistent with the Stipulation.

Regarding Item 2 (establishing the initial level for the TSCR), the Company is providing an update to those tariffs that clarifies that the Tax Savings Credit Rider is a credit to customers' bills. The updated tariffs, which delete the word "charge" and place parentheses on the values to indicate that a credit will be given, are attached.
