Dear Ms. McNeal:

Pursuant to Rule 4906-3-03(A) of the Ohio Administrative Code, Firelands Wind, LLC ("Applicant") files this Preapplication Notification Letter with the Ohio Power Siting Board ("Board") regarding its proposed wind-powered electric generation facility.

The proposed facility is a wind-powered electric generation facility located in Huron, Erie, and Seneca Counties, Ohio. The wind facility is expected to have a maximum total generating capacity of approximately 298.2 megawatts. The Applicant will provide clean renewable energy to electricity consumers.

The public information meeting will be held from 5:00 p.m. to 7:00 p.m. on Thursday, November 15, 2018, at the Bronson-Norwalk Conservation League, 295 Town Line Rd 151, Norwalk, Ohio 44857.

The Applicant anticipates filing its application with the Board within 90 days after the public information meeting. Construction of the facility is estimated to begin in the first quarter of 2020, resulting in commercial operations in the fourth quarter of 2020.

At this time, the Applicant does not anticipate that it will be filing any requests for waiver from the Board's rules regarding the electric generation facility.
